Eligibility Criteria for Serial #21 to Serial #23: - BS Nursing from an Institute recognized by Pakistan Nursing Council (PNC) OR General Nursing (03-Years) Diploma AND 01-Year Midwifery Diploma (for female candidates) OR 01-Year Specialization Diploma Permanent PNC Registration. Verification of General Nursing, and Midwifery / Specialization Diplomas from the issuing Board OR PNC

Terms and Conditions: Age limits shall be considered as per Govt of Baluchistan's existing policy. Interested and eligible candidates from all over province can apply for the said positions. Eligible candidates must submit two sets of attested copies of all educational credentials, professional experience, local / domicile certificate, CNIC, 4 passport-size photos along with updated CV. Candidate working in government, semi-government and autonomous organizations should apply through proper channel with NOC issued from the employer / parent department. Number of positions can be increased or decreased. No TA/DA is admissible for the interviews. Nature of appointment shall be contractual /adhoc for a period of 2-year with the first year as a probationary period. The contractual / adhoc tenure is extendable on the basis of excellent performance certificate issued by the concerned head. Selection shall be purely on merit basis and canvassing in any manner may lead to disqualification of the candidate. The Candidates terminated / dismissed prematurely from any government or non-government posts / positions on ground of discipline, moral turpitude, financial embezzlement or criminal offences are ineligible to apply. Concealment of facts or submission of any counterfeit document shall lead to dismissal from the position followed by legal disciplinary action. The Divisional Health Committee Quetta reserves the right of canceling the interview process without assigning any reason.
